Monthly Prize Draw Terms & Conditions

("Terms & Conditions")

1. Organiser

The monthly prize draw is organised and administered by GoodWrap Recycling Ltd ("the Company").

2. Eligibility

This promotion is open to all customers, who utilise our services directly, or indirectly through Pro Clima NZ Ltd ("Pro Clima"), and follow the entry criteria during the promotional period.

Employees of the Company, their immediate family members, and anyone professionally connected with the promotion are not eligible to participate. Participants must be residents of New Zealand and aged 18 years or older.

3. Entry Conditions

To participate, returned bags must contain clean material, as per the terms set out in the Letter of Intent / signed Formal Agreement between Pro Clima and the Company.

Entry allocation is as follows **PER CLEAN BAG:**

- 1 x 30kg bag = 10 x monthly entries.
- 1 x 15kg bag = 5 x monthly entries.
- 1 x 12kg bag = 4 x monthly entries.
- 1 x 9kg bag = 3 x monthly entries.
- 1 x 6kg bag = 2 x monthly entries.
- 1 x 3kg bag = 1 x monthly entry.

No limit applies to the number of entries per person/customer as long as the entry criteria is met.

No additional payment or fee is required to participate.

An entry becomes valid once an Impact Receipt has been sent to Pro Clima and / or the entrant.

The Company reserves the right to inspect and verify compliance with eligibility and entry conditions and may disqualify any entries that do not meet the standards of cleanliness or authenticity.

4. Promotion Period

Each draw relates to one calendar month and includes all valid entries received during that month.

The Company reserves the right to modify or terminate the promotion at any time without prior notice.

5. Prize

The prize for each month will be specified in promotional material published by the Company.

The prize is:

- non-transferable;
- not redeemable for cash; and
- subject to substitution with a prize of equal or greater value at the Company's discretion.

6. Determining the Winner

The winner will be randomly selected via a secure, trusted and unbiased online platform. The prize draw will include all eligible participants. The Company reserves the right to verify the eligibility of the winner before awarding the prize.

The winner will be announced during the first week of the following month. The winner will be notified via the contact information provided during entry. If a winner is found to be ineligible or cannot be contacted within 7 days of notification, the Company may redraw.

The winner will be notified using the contact details provided at the time of entry. The Company may also at its discretion publish limited details (e.g. first name and region)

on its social media channels of winners, and by entering you agree to such publishing by us of such information.

The Company will distribute the monthly prize to Pro Clima for their distribution to the prize winner and will not be responsible for any delays or issues with prize delivery once the prize is passed to Pro Clima for fulfilment.

7. Personal Information

By participating, participants consent to the collection, storage, use and disclosure of their personal information for the purposes of administering the promotion and as otherwise set out in these Terms & Conditions. This includes disclosure to Pro Clima for prize fulfilment and disclosure of limited winner information as set out above.

Participants also consent to the use of their name, likeness, image and/or photographs for reasonable promotional, marketing and publicity purposes (including social media and marketing materials), without further compensation.

The Company will manage personal information in accordance with the Privacy Act 2020 and its Privacy Policy. Participants have the right to access and request correction of their personal information.
