Privacy Statement

This statement explains how and when Pro Clima NZ Limited ('we', 'our', 'Pro Clima') collects personal information, what we do with it, and your right to see or change it.

All information collected through or in connection with this Site is controlled, stored and held by Pro Clima or its web service provider(s) in accordance with the Privacy Act 2020.

As well as our *Terms of Use*, this Privacy Statement governs your access to and use of the proclima.co.nz (the 'Site'). You should ensure that you read our Terms of Use in conjunction with our Privacy Statement.

Purpose

The purpose of this Privacy Statement is to let users of the Site know when we collect personal information and what we do with it.

We do not use, share, sell or transfer personal information in connection with the Site except as set out in this statement, or as otherwise set out on the Site (including in terms linking to the Site).

Personal Information

We may collect personal information when you:

We may collect your personal information in order to:

- bill you and to collect money that you owe us, including authorising and processing credit card transactions

- protect and/or enforce our legal rights and interests, including defending any claim
- fulfill any other purpose authorised by you or legislation

Besides our staff, we may share this information with:

- any business that supports our services and products, including any person that hosts or maintains any underlying IT system or data centre that we use to provide our Site or other services and products
- any business that supports our services and products for the purpose of authorising and processing credit card transactions
- a person who can require us to supply your personal information (e.g. a regulatory authority)
- any other person authorised by the Privacy Act or another law (e.g. a law enforcement agency)
- any other person authorised by you

Use of Cookies

This Site uses cookies to assist with improving your web browsing experience. A cookie is a text file which carries small pieces of data sent by a web server. This cookie is then stored by your browser so that the next time the page is referenced, the cookie is returned to the server. The purpose is to tell a web server that you have returned to a specific page.

We use cookies for record-keeping purposes and to enhance functionality on our Site. You may deactivate or restrict the transmission of cookies by changing the settings of your web browser. Cookies that are already stored may be deleted at any time.

Non-Personal Information

Our Site records standard information such as time, date and URL of request (the web page you arrived from) via our web servers. This information is recorded by all web servers and is used to improve the functionality, structure and performance of our Site.

When you use the Site our server logs certain details provided by your browser this may include, but is not limited to, the following information:

- date and time of your visit
- duration of your visit
- parts of the Site you visited
- your anonymous IP address
- information from your device accessing the Site (device type, operating system, screen resolution, language, country you are located in, and web browser type)
- the domain name of the referring Site (e.g. the previous Site that you visited)

We analyse this non-personal information for certain trends and statistics, such as which parts of the Site users are visiting, which features or services are most popular and to measure the effectiveness of advertising. We process this usage data in Matomo Analytics for statistical purposes, to improve our Site. We do not disclose information about individuals except for the reasons set out above.
